WHEREAS, at the JULY-DECEMBER 2002 Term of the Honorable 113TH District Court of Harris County, Texas on the 19TH day of DECEMBER, 2002, Plaintiffs, MARY F. ROBERTSON, MARY KATHRYN ELLIOT, and DENNIS R. ELLIOT, recovered a judgment against Defendant, JEFF BARNETT a/k/a JEFFREY BURNETT d/b/a J.B. CONTRACTORS, for the sum of \$55,000.00 for Plaintiffs' actual damages; prejudgment interest in the sum of \$4,957.53; post-judgment interest on the total sum at the annual rate of 10% until the judgment is satisfied; and services fees of \$58.00 in Harris County, \$55.00 in Galveston County, and \$75.00 for a private process server; plus all cost of said suit (as itemized in the attached cost statement, excluding cost due the County); which said judgment debtor ought now to pay. FURTHER, the Court took judicial notice of the usual and customary attorney fees should writ be granted to the Texas Supreme Court and determined reasonable and necessary attorney fees to be \$5,000.00 in such an event. THE COURT ORDERS such execution issue in favor of Plaintiffs' counsel, Daniel L. Sanders, directly.

NOW, THEREFORE, YOU ARE HEREBY COMMANDED, that of the Chattels, Personal Property or Real Estate, subject to execution by law of the said JEFF BARNETT a/k/a JEFFREY BURNETT d/b/a J.B. CONTRACTORS, you make, or cause to be made, the sum or sums, with interests as shown above, together with your legal fees and commission for collecting the same. REMIT from recovery, first: all Court Costs, due the county, to the District Clerk of Harris County, Texas, retaining for yourself costs of sale; then remit balance of recovery in said judgment to proper parties for the amounts shown herein; all in accordance with the statutes of the State of Texas.

HEREIN FAIL NOT, to make due execution and return of this Writ, within 90 days from this date.
